**GOODWILL OPERATIONAL AGREEMENT OF NON-EXCLUSIVE LICENSE BY and BETWEEN
'NETWORK OF SCIENTIFIC JOURNALS OF LATIN AMERICA AND THE CARIBBEAN, SPAIN
AND PORTUGAL (Redalyc)' HEREINAFTER REFERRED TO AS 'LICENSEE', OF THE ONE
PART
AND "Vilniaus universitetas", MEMBER OF THIS SYSTEM, HEREINAFTER REFERRED TO
AS 'LICENSOR', OF THE OTHER PART**

WITNESSETH

I. Whereas, Licensee (**Redalyc**), is hereby represented by its General Director Dr Eduardo Aguado López:

a) Whereas, Licensee is a project strictly academic supported by the Autonomous University of the State of Mexico (UAEM), and, consequently, be a scientific organization.

b) Whereas, Licensee is an online information system of scientific journals that offers free access to full texts of its collection's articles.

c) Whereas, Licensee's principal place of business is at Toluca 815, house 35, Olivar de los Padres, Álvaro Obregón, Postcode 01780, Mexico City, Mexico, and whose website is "Redalyc" <http://www.redalyc.org>.

d) Whereas, Licensee has the capacity to fulfil the promises of this Goodwill Operational Agreement of Non-exclusive License.

II. Whereas, Licensor **INSTITUTION** is hereby represented by its Legal Representative Vice-Rector prof. Edita Sužiedėlienė (2021-04-01 Rector's power of attorney RI-135)

a) Whereas, Licensor is a public (educative institution, research centre, etc.) registered in Lithuania, legal entity code 211950810, whose principal place of business is at 3 Universiteto st., LT-01513 Vilnius, Lithuania.

b) Whereas, Licensor shall protect and support before Licensee the submission of the following journals for the assessment of their scientific editorial processes, which journals, if approved, shall be the subject matter hereof.

c) Whereas, Licensor shall act on behalf of any author and co-author who publishes articles in the aforementioned journals, hereinafter referred to as ***the Journals***.

RECITALS

I. Licensee agrees as follows:

a) Licensee shall disseminate transparently the works and materials contained in, provided and included by ***the Journals***, so that the scientific community may consult them via **Redalyc** website: <https://www.redalyc.org>

b) Licensee shall not own ***the Journal's*** marketing rights of contents and materials, nor their logos, trademarks and trade names. Licensee is, therefore, under no obligation to give payment royalties for their publication or use.

- c) Licensee shall not infringe author moral rights, and therefore, shall maintain the integrity of information, Licensee shall not modify or alter it producing imprecision or violating of **the Journals** and authors' image, save for those modifications which are necessary for its electronic publication. Licensee includes in each work published online an unalterable index card, which contains the journal's authorship and publishing information with which the journal was originally published.
- d) Inasmuch as technological development allows it, Licensee shall offer a particular interface for **the Journals**, where consultation of statistics and bibliometric indicators in open access shall be possible.
- e) Licensee shall, on all occasions, offer portal users access to complete information of **the Journals**, as well as hyperlinks to **the Journals**' main websites, to their institutions, to their guidelines for authors and to their contact email.
- f) Licensee shall not violate **the Journals**' decision of giving their contents to any other newspaper and periodicals library, website, indexing system that they esteem best. This agreement, therefore, does not imply exclusivity to Licensee.
- g) Licensee shall furnish **the Journals**' editor, without charge, with an electronic tagging tool for the generation of JATS XML, called **MARCALYC**, and shall offer training to use it.

II. Licensor agrees as follows:

- a) Licensor shall upload contents that shall not infringe copyright, such contents, therefore, shall possess licenses required for their distribution via printed and electronic means.
- b) Licensor shall upload licit contents that shall not violate third parties' rights such as privacy or good reputation.
- c) Licensor shall upload to the platform any new entry and inform via email any changes made to the basic information of **the Journals** or to their committees and hyperlinks.
- d) Licensor shall authorise **Redalyc** to utilise trademarks, logos and symbols that identify **the Journals** in order to fulfil the subject matter hereof and in accordance with the boundaries established herein.
- e) Licensor shall authorise **Redalyc** to insert, for the duration of this agreement, hyperlinks in its website <https://www.redalyc.org> that redirect to **the Journals**' and their publishing institution's website.
- f) Licensor shall, in printed and electronic versions, inform that journals are accredited the evaluation process established by **Redalyc** "is indexed in the Redalyc Scientific Information System".
- g) Licensor shall insert advertisements of **Redalyc** from the moment it joins the project provided that this does not violate the journal's internal policies.

- h) Licensor shall insert in its home page a hyperlink to **Redalyc** using the image **Redalyc** provides to that end.
- i) Licensor shall send to **Redalyc** the journal's contents material prior to 2016 in PDF or word processor format, and if possible, all material in JATS XML format (one per article, contribution or review).
- j) Licensor shall send to **Redalyc** the material since 2016 onwards in JATS XML format (one for each article, collaboration or review). The tables of contents in PDF or word processor format should also be submitted. In the event that the Journals do not have their material in JATS XML format, **Redalyc** will make available, at free cost, the technological tagging tool mentioned in section I, paragraph g), of this agreement.
- k) Licensor shall allow **Redalyc** to generate, through each JATS XML file send by the journal, and validated by **Redalyc**, the electronic formats: ePUB, HTML, an intelligent viewer and mobile viewer for articles, and to disseminate these materials in its website: **Redalyc <https://www.redalyc.org>**, as well as to generate, for interoperability purposes, files that guarantee greater visibility for ***the Journals***.
- l) Licensor shall send to **Redalyc**, in case the Journals do not use the Marcalyc tagging tool, together with the sending of their JATS XML, each journal must send the corresponding PDF formats to the same articles.
- m) Licensor shall allow **Redalyc** to generate, through each JATS XML file created by **Marcalyc** tagging tool, the electronic formats: ePUB, HTML, an intelligent viewer and mobile viewer for articles, and to disseminate these materials in its website: **Redalyc <https://www.redalyc.org>**, as well as to generate, for interoperability purposes, files that guarantee greater visibility for ***the Journals***.
- n) Licensor may use the PDF files of its marked articles, under an automatic generation format offered by **Marcalyc** tagging tool, or upload their own PDF files to be displayed on the platform
- n) From the Marcalyc tool, each magazine can generate the PDF files of its marked articles, under an automatic generation format offered by Marcalyc, or upload their own PDF files to be displayed on the platform. It is not advisable to generate new PDF files from **Marcalyc** tagging tool if each journal publishes its own PDF on their website.

III. Use of Marcalyc tagging tool:

To have access to the technological tagging tool **Marcalyc** each of ***the Journals*** shall observe the following:

- a) To request **Marcalyc** tagging tool service responsible editor shall send an email to editores@redalyc.org.
- b) In doing so, responsible editor accepts and declares the journal is an open access journal, that it does not charge for publishing or processing articles and that he or she is willing to attend and access the JATS XML certificate course online in **Redalyc**.

- c) Send to editores@redalyc.org as soon as possible full name, Skype account and email of he or she who shall contact **Redalyc** for the use of **Marcalyc** tagging tool.
- d) The user must not share the account that, for the use of the **Marcalyc** tagging tool is provided by **Redalyc**.
- e) They shall not eliminate captions or logos of downloadable items generated by **Marcalyc** tagging tool: ePUB, HTML, PDF and similar generated through XML formats.

IV. Both parties agree as follows:

- a) This **Goodwill Agreement** is without consideration, no remuneration or royalty for either party is established since this is a non-profit scientific project for the academic benefit of both parties.
- b) The period of this agreement is indefinite, however, either party may terminate this agreement giving official notice in writing to the other party accounting for its decision, prior to 60 (sixty) calendar days. Neither of them shall present complaints for nor be liable to compensate for damages. Should notice be not given to the other party within the said term, the agreement will not be terminated but after such period of time.
- c) The transition to article tagging technology using the JATS XML standard for all Redalyc journals began on October 1, 2016 and will be a continuous transition. Journals should mark their material from 2016 onwards, inside or outside the Marcalyc tagging tool, generate the respective JATS XML and send them to Redalyc.
- d) This agreement shall be interpreted and construed and obeyed in accordance with mutual trust, academic ethics of both parties and their representatives.

THE PARTIES DECLARE THEY HAVE READ THIS AGREEMENT AND AGREE WITH THE CONTENT THEREIN, CONSISTING OF 5 (FIVE) PAGES.
